

END USER LICENSE AGREEMENT (EULA) FOR BMPFast

IMPORTANT – READ CAREFULLY: This End User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity, hereinafter "Licensee") and **BMP SOFT, LLC** ("Licensor") for the BMPFast software product, which includes computer software, license keys, and any associated media or documentation (collectively, the "Software").

BY INSTALLING, COPYING, ACTIVATING WITH A LICENSE KEY, OR OTHERWISE USING THE SOFTWARE, YOU AGREE TO BE BOUND BY THE TERMS OF THIS EULA. IF YOU DO NOT AGREE, DO NOT INSTALL OR USE THE SOFTWARE.

1. GRANT OF LICENSE

Subject to your agreement to and continuing compliance with this EULA, and payment of the applicable license fees, BMP SOFT, LLC grants you a limited, non-exclusive, non-transferable **yearly subscription license** to use the Software.

- **License Key:** The Software requires a valid license key for activation. The license is valid for one (1) year from the date of purchase. You are granted the right to use the Software on the number of devices explicitly authorized by the license key you purchased from bmpfast.com. Access to the software and subsequent updates requires an annual renewal of the license key.

2. RESTRICTIONS

You may not:

- Share, distribute, or publicly post your license key.
- Reverse engineer, decompile, disassemble, or attempt to discover the source code of the Software.
- Modify, adapt, translate, or create derivative works based on the Software.
- Rent, lease, lend, sell, or sub-license the Software to third parties without prior written consent from BMP SOFT, LLC.

3. REFUND POLICY

BMP SOFT, LLC offers a full refund for any purchased license key provided the Software remains **unregistered** (meaning the license key has not been activated or used). Once a license key has been activated or used to register the Software, all sales are considered final and no refunds will be issued.

4. INTELLECTUAL PROPERTY

The Software is licensed, not sold. All title, ownership rights, and intellectual property rights in

and to the Software, including any updates or modifications, remain the exclusive property of BMP SOFT, LLC.

BMPFast is designed as a tool to assist in the analysis of stormwater systems. However, the Software **does not** replace professional engineering judgment, expertise, or the necessity for independent verification.

- BMP SOFT, LLC assumes no responsibility for errors in engineering design, regulatory compliance failures, structural failures, or environmental impacts resulting from the use of the Software.
